# ***Financial Statements and Obligations***

**Dues:** The dues of Conewango Valley Country Club (CVCC) are annually set by the Board of Directors.

Golf members who pay their dues in full by October 31<sup>st</sup> of the preceding year will receive a 5% discount and five (5) guest greens fee passes for the current dues year. If dues are paid in full by December 31<sup>st</sup> of the preceding year, members will receive five (5) guest greens fee passes. All members are expected to have their dues paid in full by April 1<sup>st</sup>. A member is not entitled to use the club facilities until current year dues are paid in full.

**Refunds:** There will be no refunds unless specifically approved by the Board of Directors and only in extenuating circumstances.

**Minimums:** A monthly (April-October) food and beverage minimum has been established by the Board of Directors for each membership category: Family - \$150 / Individual - \$100 / Social - \$100 / See schedule for minimum for the 35 yr old to 40 yr old category. A monthly (April-October) capital improvement and debt reduction fee has been established by the Board of Directors for each membership category: Family - \$40 / Individual - \$35. These charges also apply to the Intermediate (Under 35---40 yr old) Membership categories.

**Charging Privileges:** A monthly statement shall be sent to each member showing his/her indebtedness. All charges during a calendar month will be billed during the first five (5) days of the following month. The amount billed is payable during the month billed. Member accounts not paid before the first day of the month following the billing month are considered thirty (30) days past due. All accounts that are thirty (30) days past due and are not paid in full within another thirty (30) days (then being 60 days past due) will, in addition to other actions listed below, be charged a 1-1/2% per month interest charge. In order to be processed in the billing month, payments must be received five (5) business days before month end.

Member accounts past due sixty (60) days will, in addition to the interest charge specified above, result in the automatic suspension of the member. Suspended members shall have their names and delinquent amounts posted on the official club bulletin board and also published in the newsletter. Suspended members may not use any club facilities. Any member with amounts past due ninety (90) days will be requested by the Board to offer reasons why the member should not be expelled. Specific questions concerning charges should be directed to the office manager. Any member turned over to collection, will be responsible for all collection fees.
